PRESENTATIONS:

A. Presentation of 1st Quarter Recycling Updates - Ivette Rodriguez, Mid-Valley Disposal, Inc.

Ms. Rodriguez presented 1st quarter recycling updates and introduced Kasey Austin, Public and Government Relations person. Huron Lumber recognized as Recycler of the Year 2017 and provides a place to recycle batteries and light bulbs. Newsletters are on website and flyers would be posted in prominent places to educate public in composting and recycling contamination. This is dictated by Cal Recycle who worked with city for three consecutive years to get us to this point. At present 3.0 lbs. of recycling is generated per person per day and we need to get it down to 2.8 lbs. per person. Mayor Leon requested a tour of the MERF facility in Fresno and Ms. Rodriguez would look into that.

City Attorney Costanzo reported city supported the Petition for separation and provided resolution with findings by Council that students were deprived of education because of the distance and proven statistics.

Mayor Leon announced on July 13th two EOC buses would provide transportation to attend meeting where petition to separate from CHUSD would be heard before the State Board of Education in Sacramento. Those interested could sign up at city hall and buses would leave from City Hall at 4:30 a.m. and return by 5 p.m.. Mayor Leon said they were confident but people needed to be present and asked all to attend. If separation was successful it would be an economic benefit to the city.

VIII. <u>CHIEF OF POLICE'S REPORT</u>: Chief Turegano stated he would need to purchase a decimal meter to test noise levels and asked they call the station when this was happening. June's report was provided. Three (3) new electrical vehicles will be coming to the HPD with

one for the School Resource Officer; one for the City Manager and one for Council/Chief of Police. It would be used for Chief's meetings.

There was one homicide this month making it three homicides for 2017 and thanked Mayor Leon for his words from the heart on city newsletter. HUD works with police department to rid of gang members on their sites. Congratulations to HMS and Councilmember Pimentel for their recognition of being National Schools to Watch.

- FINANCE DIRECTOR'S REPORT: The city will receive \$20,000 in grant monies for each Χ. electrical vehicle purchased for HPD for a total of \$60,000. The city received \$520,000 for the Plazcita Project and the Couture family is working with the city in that regard. Mayor Leon was elated with this news.
- XI. CITY ATTORNEY'S REPORT: City Attorney Costanzo reported the foreclosure for the "O" Street subdivision trial was continued.
- **SENIOR CENTER SITE COORDINATOR:** Mayor asked if any trips were scheduled. Ms. XII. Veliz said not at the moment but would look into that.
- CITY COUNCIL COMMUNICATIONS/COMMENTS: Councilmember Pimentel reported XIII. HMS was recognized as a Schools to Watch Program in Washington, DC and while there Congressman Valadeo provided them with a tour of the White House, Pentagon and Capital.

Mayor Leon stated he supported AB 964 Calderon provided low income families for electric cars good to FCRTA, Moses Stites, Director, and shared obstacles and environmental goodness.
