VII. <u>PUBLIC PRESENTATIONS</u>: Davin Carroll, Climate Change Solutions, thanked City Council for their letter of support and assured them other cities would follow suit.

- VIII. <u>CHIEF OF POLICE'S REPORT</u>: Chief Turegano contacted various agencies regarding services for the homeless and MAP would address Council on April 4th. Another Community with the Cop held this weekend by Sgt. Pellitier with ten in attendance and the responses would be posted in the city newsletter.
- Working on sewer plugs; a major water leak at JPCC built in 1960's which made it difficult to find shut off valve. Since Couture Farms is at peak season he was unable to fix leak until today when it rained to turn off water. Last Friday they installed the five (5) LED lights in the ally of the JPCC and felt another two were necessary and were on order. Lettuce started last Friday too. A big clean up scheduled at both homeless camps at M & 10th Street and at Huron & Central Avenue by placing refuse bins. The basin by the United Health Centers excavation was cleaned out along with tree roots thanks to their heavy equipment.
- **X.** <u>FINANCE DIRECTOR'S REPORT:</u> Adm. Assist. Veliz stated Senior Site Coordinator Walker wanted to take the seniors to the Tache Palace Community Breakfast on April 27th as it was free. It would be up to Council as they had done away with this to not promote gambling.

Mr. Castro reported Fresno County Housing Authority is looking for a site to build a complex and is thinking of selling them four of the ten acres belonging to the Successor Agency after the RDA was abolished. The Department of Finance would do away with all Successor Agencies July 1st, 2018 and staff would like to ask Fresno Housing Authority to build a new city hall in exchange for the acreage. Clarification was made that the property belonged to the Successor Agency and would be doing the transaction not the City Council. City Attorney Costanzo asked for a consensus.

CONSENSUS: To authorize the City Manager to spend \$80,000 to purchase the 10 acres and provide 4 acres to the Fresno Housing Authority for their building of a complex and have them build a new city hall for the city behind the new Police Department and use the remaining 6 acres for a soccer field.

The consensus was unanimous 3-0.
